The home, known as Our Modern Manor, was purchased by the Vincents and their renovation journey has been promoted on Instagram and Facebook. Special thanks to Gina Nellis and Cora Spencer, who are leading this fundraising effort, and for the many volunteers that will come together to make it happen! All proceeds from tours, sponsorships, and advertising support the agency's mission.

The staff has been incredibly busy addressing the needs of families and child care partners. The pandemic resulted in significant numbers of child care facility closures, making it extremely difficult for families to locate the child care they need in many communities. We are working with partners at the local and state level on recruitment and retention efforts to build the child care capacity in communities that are lacking child care slots for working parents. Employers are engaged in this work more than ever before, recognizing that child care capacity in the area significantly impacts their workforce. Part of our recruitment strategy includes the launch of the Early Childhood Workforce Training Center in September. See a separate story for more details on this exciting initiative.

The Board of Directors will be hosting a retreat in September to examine the status of the agency's strategic plan and make any needed mid-course adjustments. A capacitybuilding grant from the Kansas Health Foundation will support this work as we ensure that the agency is positioned to address the challenges ahead including navigating the transition of several members of the agency's leadership team. The recruitment process for new board members is beginning soon and interested individuals are encouraged to contact me for more information.

As always, all we do focuses on fulfilling our mission to support the healthy development of young children by improving access to high-quality child care and resources for families and early childhood professionals. We want children and families to get off to a great start, knowing the importance of the earliest years. Your support makes a difference each and every day, and we are grateful.

## **PROGRAM HIGHLIGHTS & HAPPENINGS**

### MAPPING CHILD CARE DEMAND AND THE SUPPLY OF CARE

Working parents want to secure high-quality child care for their young children. Yet parents often struggle to find high-quality care that fits their work schedules and is convenient and affordable, among other factors. Parents do not always know what their options are and where child care is available. In addition, limited child care slots in some communities can result in long waitlists and cause families to turn to lower-quality or unlicensed arrangements. This struggle to find care can lead families to make do with a "good enough" arrangement in the short term and can create instability in children's care arrangements over time.

Since launching the Point in Time Data feature on May 18, 2021, Child Care Aware<sup>®</sup> of Kansas's website has received over 1,000 unique visitors specifically looking for information about the supply and demand of child care in Kansas communities. This Point in Time Data was created to assist communities – including families, employers, and other community leaders – across Kansas as they work to address critical child care shortages.

Every hour, roughly two Kansas are downloading data, and our hope is that they're using this information to evaluate local needs for high-quality child care. This new tool offers communities up-to-date, relevant information so collectively we can move towards action. With one click, you can review changes in the supply and demand of different types of child care over the last three years. You can explore information on the average cost of child care, the availability of evening, weekend, and overnight care, and the number of programs that accept child care subsidy or participate in the Child and Adult Care Food Program.

#### EARLY CHILDHOOD WORKFORCE CENTER TO LAUNCH IN SEPTEMBER!

One of the major hurdles to child care access in Shawnee County is the lack of qualified teaching staff. A number of child care center directors in the community report struggling to hire staff and some have reported having to limit their current enrollment as classrooms are closed due to the limited amount of staff available. In response to this broad-based need, Child Care Aware® of Eastern Kansas is launching the Early Childhood Workforce Training Center on September 13, 2021.

The 'Center' will prepare and equip participants for a teaching career in an early childhood classroom by combining professional development with observations and classroom experiences. This 'Center' will be housed at the SENT Prep Academy site. Enrolled participants will complete a 60-hour preparatory career training track which provides all the initial training and background checks required by the Kansas Department of Health and Environment. Once this two-week training session is completed, participants may choose to continue with an experiential classroom teaching track. This track offers the opportunity to gain classroom experience in a high-quality early childhood classroom, similar to an internship or student-teaching experience.

Betsey Litscher, Early Childhood Workforce Training Center Coordinator, will oversee the project, helping each student create a professional learning plan that sets them on the path towards their professional goals in the early childhood field. Following the program's completion, the Early Childhood Workforce Training Center will contact participants to track their employment and career goals.

This exciting project, funded through a Preschool Development Grant\* through the Kansas Children's Cabinet and Trust Fund, will help us evaluate effective recruitment strategies to grow the pool of qualified early childhood teachers in the community and will serve as a model for other similar efforts throughout the state!



**SUSTAINABILITY GRANTS OFFER MUCH NEEDED SUPPORT TO PROVIDERS** Child Care Aware<sup>®</sup> of Kansas, in partnership with Kansas Department for Children and Families, received over 3,150 applications for Child Care Sustainability Grants. With 84% of eligible child care programs applying, this demonstrates the significant need for continued support for Kansas child care programs.

To help ensure that child care programs in our region know about available grant opportunities and are successful with their application, Child Care Aware<sup>®</sup> of Eastern Kansas now has a Grants Navigator. Crystal Smith joined our team in May, and her sole focus is supporting child care programs through the grant process. Child care providers have expressed their gratitude for having a regional point of contact and someone they know will be there to assist them with their questions related to grants that help them sustain their child care businesses. Several have said that the grant support they have received has allowed them to stay in business, and that without it they would have had to close their doors to children and families.

Kansas child care providers have worked tirelessly throughout the pandemic, even when other businesses closed. Prioritizing the health and safety of young children comes with increased costs for child care programs, at a time when revenue for child care businesses has been unpredictable.

Child Care Aware<sup>®</sup> of Kansas partnered with Kansas Department for Children and Families to bring \$49 million in financial support for child care program operations. The Sustainability Grants program will provide \$5,000 for family child care providers and up to \$60,000 for large child care centers. Any licensed child care program in the state that meets compliance standards is eligible to apply.

Young children are still in need of high-quality child care. When we ensure all families have access to quality child care options – regardless of income level or where they live – we build the critical infrastructure necessary for our businesses to succeed, our communities to flourish, and our children to grow into happy, healthy, productive Kansans.
