Understanding Your Child Care Options

There are many child care options available, depending on what your family is looking for from a provider. The most significant decision is whether you prefer a child care center or an in-home provider.

Center-Based

Child care centers often offer more options than in-home providers, with structured environments, age-specific activities, and set hours. They include Headstart programs and preschools.

Home-Based

Home-based child care is typically offered in the provider's home, with flexible scheduling and age ranges. Providers must follow state and federal quidelines and offer daily activities.

School-Age

School-age programs serve k-6 graders, typically before/after school and during summer break. Often run by schools or community partners to provide care outside the traditional school year.

If you receive Child Care Assistance from the Kansas Department for Children and Families, certain relatives may be eligible to provide home-based care for your children.

Determine Your Budget

Your budget will play a big part in the final decision. Your weekly or monthly child care cost will vary depending on the type of child care you choose, your specific provider and your child's age.

Making a Decision

Meet with Multiple Providers

Meeting with multiple child care providers lets you compare environments, teaching styles, and safety, helping you find the best fit for your child's needs and your preferences.

Explore: Start your search early. Finding the right child care may take time.
Evaluate: Consider your child's learning style, family needs, and the location/hours of care.
Observe: Visit at least three programs, interview providers, and tour the facilities.
Decide: Review your notes, trust your instincts, and address any concerns.
Be Involved: Partner with your child care provider, and visit your child anytime.

Use the checklist at the end of this packet to help guide you in your child care search.

WHAT TO ASK

Asking the right questions can help you learn more about a provider. Ask what learning activites are offered in the program and how the provider ensures health and safety.

CHILD CARE COSTS AND ASSISTANCE

Child care costs vary by factors like your child's age, program activities, provider qualifications, and location. Financial assistance is available through various subsidies and programs, so explore these options to reduce expenses.

Dependent Care Flexible Spending Account (FSA)

This tax advantaged financial account allows an employee to set aside earnings to pay for care. Money deducted from an employee's pay into an FSA is not subject to payroll taxes, resulting in substantial payroll tax savings.

Military Subsidies

You may qualify for child care subsidy assistance if you are an Active Duty military family or Active Duty National Guard (AGR) serving under Title 10 or Title 32, United States Code (U.S.C.). Visit www.usa.childcareaware.org for information on how to apply.

Child Care Assistance

You may be eligible for the Earned Income Tax Credit. Call 1-800-829-1040 or visit www.irs.gov for more information. Some facilities offer discounts for multiple children or sliding fees. Businesses and communities may also have programs to help with child care costs.

The Kansas Department for Children and Families (DCF) has funding available to help income eligible families pay for child care in a regulated facility, or by a relative caregiver. Call 1-888-369-4777, visit www.dcf.ks.gov, or visit childcareinkansas.com for more information.

TIPS FOR A SUCCESSFUL PARTNERSHIP

Even after your child is enrolled, it's important to stay involved with their care by volunteering, asking for updates, and checking in with your child about their experience.

Tips for a Successful Partnership with Your Child Care Provider

- 1 Pick up your child on time. If an emergency prevents you from being on time, call.
- 2 Communicate openly with your provider about your child and his/her progress, as well as any concerns you may have.
- **3 Find ways to get involved.** Working together is key to making the partnership work.
- 4 Follow the agreed upon contract and policies. Keep a copy for your records. If you feel that the child care provider is not adhering to their own policies, mention it. Small issues can quickly become big issues.
- **5 Pay on time.** Your child care provider is operating a business and depends on you.

Checklist for Choosing Quality Child Care

You have a lot to consider when selecting a child care provider. Use this checklist to help determine the right provider for you.

What to look for

- □ Staff are engaged, and provide individual, positive attention and handle conflicts calmly. □ Staff interact at the child's level, promoting listening, talking, and play.
- □ The environment is cheerful, clean, and safe with well-maintained equipment.
- □ A daily schedule includes free play, naps, meals, outdoor/indoor play, and learning activities.
- □ Meals/snacks are nutritious, with a posted menu offering healthy choices.
- □ The outdoor play area is safe, fenced, and supervised.
- Emergency numbers and evacuation routes are clearly posted.

Infant and Toddler care considerations

- Caregivers engage by talking, describing, and reading aloud.
- □ Safe Sleep Policies and procedures are in place. Nap times are relaxed and stress free.
- Discuss procedures on feedings, breastfeeding, diaper changes, toilet learning, and naps.
- □ The setting is child-proofed for safe crawling and walking.

Preschool care considerations

- □ The schedule is flexible to accommodate individual needs.
- □ The provider actively interacts with the children.
- Consistent limits are set to help children learn to make their own choices.

School-age care considerations

- Age-appropriate activities are available when school is out.
- □ Adequate space is provided for homework.
- □ The provider supports children with projects, homework, and engaging activities.
- Discuss options for child care on no school days.

General considerations

- Ensure the cost fits your budget. Understand what is included in cost and any additional fees.
- Confirm hours and holidays align with your work schedule.
- Consider if your child will be happy and if you feel comfortable with the program.
- □ Request and contact references to learn about others' experiences.
- □ Review policies on philosophy, discipline, illness/injury, abuse and neglect, and transportation.
- □ Ensure staff and volunteers undergo references and background checks.
- □ Review staff education, experience, and tenure, including First Aid and CPR training.
- Confirm first aid kit availability and staff training to administer medication.
- Ensure the program encourages parental visits and family involvement.
- □ Review policies for drop-off/pick-up, emergencies, and child safety during transitions.
- Ask about absence/vacation policies and daily communication with parents.
- Ensure the KDHE license is posted.
